**SET-UP &**

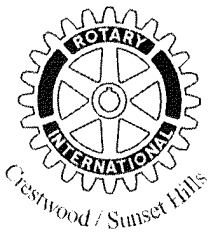
All exhibitors must set-up on Friday evening, March 23, 2012, at the set-up time assigned to them on the final instruction sheet mailed to each exhibitor. NO exhibitor will be allowed to park on the parking lot of Lindbergh High School during posted show hours. Off-lot parking and shuttle service will be provided for exhibitors.

**APPLICATIONS:**
